MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the tariff of Net One International, Inc. ("the Company") and states as follows:

- 1. International Charity Network, Inc., amended its Articles of Incorporation to changes its corporate name to Charities Network International, Inc., which it then changed to Net One International, Inc. The Company has an existing approved tariff, JX-2003-0739.
- 2. Section 392.611(2) requires telecommunications providers to submit an annual report to the Commission along with other necessary information to calculate assessments. The requirements telecommunications providers must meet are further explained and codified in 4 CSR 240-28.040 (reporting) and 4 CSR 240-28.050 (assessments).
- 3. Net One International has failed to send its required 2016 Statement of Revenue. The Company has not responded to Commission prompts regarding this outstanding item. Staff also sent its fiscal year 2017 assessment invoice based on the estimated revenues of the Company, but has not received a response and emails to the Company have failed. Staff reached out to a prior known associate of the Company, which indicated it no longer does business with Net One International. Staff has been unable to locate additional contact information.

- 4. Due to the Company's failure to comply with the applicable statutes, rules and orders, Staff moves for the Commission to cancel the Company's tariff. Staff is unable to locate record of any certificate of service authority held by the Company or any of its aliases, however, should the Company still hold a certificate with the Commission to offer any telecommunications services in Missouri, Staff would ask for cancellation of said certificate as well.
- 5. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 6. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel any certificate of service authority to provide telecommunications service in Missouri and the tariff of Net One International, Inc.
