ORDER ESTABLISHING TIME TO RESPOND

On March 24, 2023, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel or revoke the certificate to provide intrastate interexchange telecommunication service authority and applicable tariff of Westel, Inc. The Commission granted Westel, Inc. a certificate to provide intrastate interexchange telecommunication service authority in File No. TA-1993-0023.

Sections 392.210 and 392.390, RSMo set forth various requirements for telecommunications companies. Those requirements include filing an annual report, filing a Statement of Revenue report, and paying the Missouri Commission assessment.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission

may revoke the telecommunications certificate and IVoIP registration based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

- 1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 7, 2023.
 - 2. This order shall be effective when issued.
