ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: April 19, 2006

Effective Date: April 29, 2006

On April 14, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Popp Telecom Incorporated, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-95-301, the Commission granted Popp Telecom a certificate to provide intrastate interexchange telecommunications services. Popp Telecom's tariff, PSC Mo No. 1, was also approved.

Staff's motion states that Popp Telecom indicated in its confidential Statement of Revenue that it is no longer in business and no longer wished to maintain its operating certificate in Missouri. Furthermore, Popp Telecom reported no Missouri jurisdictional revenue. Popp Telecom also failed to file its annual registration report according to the Missouri Secretary of State's office, and its authority to do business in the state of Missouri was revoked

October 22, 2005. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, PSC Mo No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Popp Telecom's request to cancel the certificate and tariff included in its Statement of Revenue, the Commission finds that the certificate of service authority and accompanying tariff granted to Popp Telecom Incorporated, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Popp Telecom Incorporated, in Case Number TA-95-301 is canceled.
2. Popp Telecom's tariff, PSC Mo No. 1, is canceled.
3. This order shall become effective on April 29, 2006.

4. This case may be closed on April 30, 2006.
