ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 25, 2009 Effective Date: October 5, 2009

On September 9, 2009, the Staff of the Missouri Public Service Commission filed a motion requesting PowerCom Corporation's ("PowerCom") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-2000-350, the Commission granted PowerCom a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that PowerCom filed a *Notice of Cessation of Operations* which indicated that the company ceased operations and is no longer in business. PowerCom owes the Commission \$50.03 in assessments for Fiscal Year 2010. PowerCom is not deficient in the filing of the Company's annual report. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On September 11, 2009, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than September 21, 2009. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to PowerCom Corporation, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to PowerCom Corporation, in File Number TA-2000-350, is canceled.
 - 2. PowerCom Corporation's tariff, P.S.C. Mo No. 1, is canceled.
 - 3. This order shall become effective on October 5, 2009.

4. This case may be closed on October 6, 2009.
