ORDER CANCELING CERTIFICATE

Issue Date: December 21, 2011 Effective Date: December 30, 2011

On December 6, 2011, AT&T Corp. filed an application requesting the Commission cancel their certificate of service authority.

In Case Number TA-2009-0045, the Commission granted AT&T Corp. a certificate to provide intrastate interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services.

On December 9, 2011, the Commission directed the Staff of the Missouri Public Service Commission to file recommendation а no later than December 19, 2011. On December 19, 2011, Staff filed its recommendation. Staff's recommendation states that AT&T Corp. owes no past assessments to the Commission and is not delinquent in filing an annual report. Staff further states that the assets which allowed these services to be provided have been transferred to Southwestern Bell Telephone Company ("AT&T Missouri"). In addition, the accompanying tariffs have been adopted by AT&T Missouri. The intrastate interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services, once provided by AT&T Corp. are now provided by AT&T Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on AT&T Corp.'s request to cancel the certificate, and Staff's recommendation, the Commission finds that the certificate of service authority granted to AT&T Corp., shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide intrastate interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services granted to AT&T Corp., in File Number TA-2009-0045, is canceled.
 - 2. This order shall become effective on December 30, 2011.
 - 3. This case may be closed on December 31, 2011.
