### MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority of Intellicall Operator Services, Inc., (Company) and states:

1. On June 19, 1992, the Commission granted a certificate of interexchange service authority in Case No. TA-92-210, to the Company. The Company requested and was granted authority to change its name to Intellicall Operator Services, Inc., d/b/a ILD in Case No. XN-2003-0149. The Company has an existing tariff, No. JX-2003-1515.

2. On December 21, 2017, the Company notified the Commission that it no longer wished to retain its certification to provide interexchange telecommunications services in Missouri. In a series of communications with Staff regarding its request for cancellation. the Company requests cancel all authority provide to to telecommunications services under the name Intellical Operator Services, Inc. and Intelicall Operator Services, Inc., d/b/a ILD in Missouri.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate

of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications services in Missouri and the applicable tariff of Intellicall Operator Services and Inc, Intellicall Operator Services, Inc., d/b/a ILD.
