ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: July 21, 2006

Effective Date: July 31, 2006

On June 20, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Axces, Inc., a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-96-95, the Commission granted Axces a certificate to provide intrastate interexchange telecommunications services. The company's tariff, Mo. PSC Tariff No. 1, was also approved.

Staff's motion states Axces failed to file its annual registration report according to the Missouri Secretary of State's Office, and its authority to do business in the state of Missouri was revoked on September 14, 2005.

Staff attempted to contact Axces via mail which has not been returned as undeliverable. Axces has not responded to Staff's motion. Staff Attorney, David Meyer contacted the attorney listed in the company's 2003 annual report who

indicated that to the best of his knowledge, the company was no longer operational.

Axcres failed to file a 2005 Annual Report and its fiscal year 2007 Statement of Revenue with the Commission. The company attempted to pay its most recent annual assessment for Fiscal Year 2006 to the Commission, but its check failed to clear. Axcres has failed to reissue the check. No complaints have been filed against the company since the commencement of the Electronic Filing and Information System.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the company's lack of authority to do business in Missouri, and their lack of filing an Annual Report with the Commission, the Commission finds that the certificate of service authority and accompanying tariff granted to Axcres, Inc. shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Axcres, Inc., in Case Number TA-96-95, is canceled.
2. Axcres's tariff, Mo. PSC Tariff No. 1, is canceled.
3. This order shall become effective on July 31, 2006.

4. This case may be closed on August 1, 2006.


