### ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On February 12, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that iNetworks Group, Inc.'s ("iNetworks") certificate of service authority and accompanying tariff to provide interexchange service authority, basic local exchange telecommunications service and switched exchange access services in the State of Missouri. The Commission granted iNetworks a certificate of service authority to provide interexchange, basic local and switched exchange telecommunication service in the State of Missouri in File Number LO-2011-0021.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
