On January 26, 2022, Global Tel*Link Corporation d/b/a ViaPath Technologies filed a request to cancel the certificate of service authority granted to its subsidiary, Value-Added Communications Services, Inc. (the Company), to provide intrastate telecommunication services in the State of Missouri. The Company also requested any related tariffs be cancelled. The request states that the Company has no customers in Missouri. The Commission granted the Company a certificate of service authority to provide intrastate telecommunication services in Case No. TA-92-17.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.

The Staff of the Public Service Commission (Staff) is directed to review the request and file a recommendation regarding the cancellation of the Company's certificate of service authority and any accompanying tariffs.
