## **ORDER GRANTING EXPEDITED TREATMENT AND DIRECTING STAFF TO FILE RECOMMENDATIONS**

Issue Date: June 1, 2009

Effective Date: June 1, 2009

The Missouri Public Service Commission is granting the motions for expedited treatment filed by Holway Long Distance Company and KLM Long Distance Company ("the companies"), and is directing its staff ("Staff") to file recommendations on applications of the companies. The companies filed their applications on May 28, 2009, seeking the Commission's waiver of certain Commission regulations. The petitions include motions for expedited treatment.

Expedited treatment is subject to the following standard.

(16) Any party seeking expedited treatment in any case shall include in the title of the pleading the words "Motion for Expedited Treatment." The pleading shall also set out with particularity the following:

(A) The date by which the party desires the commission to act;

(B) The harm that will be avoided, or the benefit that will accrue, including a statement of the negative effect, or that there will be no negative effect, on the party's customers or the general public, if the commission acts by the date desired by the party; and

(C) That the pleading was filed as soon as it could have been or an explanation why it was not.

That standard has support in the motions for expedited treatment because the motions allege that:

(A) The companies desire the Commission to act by June 19, 2009;

(B) If the commission acts by that date, there will be no negative effect on the party's customers or the general public; and

(C) That the pleading was filed as soon as it could have been.<sup>1]</sup>

Therefore, the Commission will grant the motions for expedited treatment.

Having granted that motion, the Commission will order Staff to file a recommendation in an expedited fashion.

#### **THE COMMISSION ORDERS THAT:**

1. The motion for expedited treatment filed by Holway Long Distance Company is granted.

2. The motion for expedited treatment filed by KLM Long Distance Company is granted.

3. The Commission's staff shall file its recommendations as to the applications of Holway Long Distance Company and KLM Long Distance Company no later than June 10, 2009.
