#### **STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Staff Recommendation* in Case No. XN-2009-0155 and the related Tariff Filing No. YX-2009-0286 states as follows:

1. In Case No. TA-99-574 the Missouri Public Service Commission (the Commission) granted PNG Telecommunications, Inc. (PNG) a certificate of service authority to provide intrastate interexchange telecommunications services and classification as a competitive telecommunications company. PNG's service authority was extended to include basic local exchange services in Case No. TA-2001-433.

2. On October 23, 2008, PNG filed notice with the Commission of a proposed name change, intending to adopt the d/b/a PowerNet Global Communications. With this filing, PNG filed an *Adoption Notice* and a tariff *Title Sheet* with an effective date of November 22, 2008.

3. On November 4, 2008, the Commission issued its *Order Directing Filing*, directing Staff to file a recommendation in this matter no later than November 14, 2008.

4. On November 10, 2008, PNG filed a revised *Title Sheet* and requested an extension of the effective date of the tariff until November 25, 2008.

5. Commission Rule 4 CSR 240-2.060 provides:

(5) A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provision of these rules, the items required herein may be filed by a nonattorney. Applications for approval of a change of name shall include: (A) A statement, clearly setting out both the old name and the new name;

(B) Evidence of registration of the name change with the Missouri secretary of state; and

(C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.

6. In the attached Memorandum, labeled Appendix A, Staff recommends that the Commission recognize the d/b/a PowerNet Global Communications. The application clearly sets forth the old fictitious name of PNG Telecommunications, Inc. and the new fictitious name of PowerNet Global Communications. The application includes evidence of registration of the name change with the Missouri Secretary of State. The application includes an appropriate adoption notice.

7. Commission Rule 4 CSR 240-3.545(20) requires that at or before the next billing cycle an applicant notify its customers of any name change affecting customer recognition of the company.

8. In the attached Memorandum, Staff indicates that customers have been notified in compliance with this Rule.

9. PNG is not delinquent in the filing of its annual report or in the payment of its Commission assessment.

**WHEREFORE,** Staff recommends that the Commission issue an order recognizing the d/b/a PowerNet Global Communications and approving Tariff Filing No. YX-2009-0286.
