### ORDER CANCELING INTEREXCHANGE REGISTRATION

Issue Date: August 25, 2021 Effective Date: September 24, 2021

On August 12, 2021, the Commission's Staff filed a motion asking the Commission to cancel the interexchange telecommunications registration of ComApp Technologies, LLC. The Commission granted ComApp Technologies that registration in File No. XA-2018-0347, on May 18, 2018.

Staff explains that ComApp Technologies notified the Commission in its 2021 Statement of Revenue that it does not serve any customers in Missouri and requests its registration be canceled. Staff indicates ComApp Technologies' request to cancel its registration is in compliance with Commission rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that registration.

On August 12, 2021, the Commission issued an order allowing parties until August 23, 2021, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to ComApp Technologies shall be canceled.

### THE COMMISSION ORDERS THAT:

- 1. The registration to provide interexchange telecommunications services granted to ComApp Technologies in File Number XA-2018-0347, is canceled.
  - 2. This order shall become effective on September 24, 2021.
  - 3. This file may be closed on September 25, 2021.
