ORDER CANCELLING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY

Issue Date: February 28, 2022 Effective Date: March 30, 2022

On January 26, 2022, Global Tel*Link Corporation d/b/a ViaPath Technologies filed a request to cancel the certificate of service authority granted to its subsidiary, Value-Added Communications Services, Inc. d/b/a GTL (the Company), to provide intrastate telecommunication services in the State of Missouri. The Company also requested any related tariffs be canceled. The Commission granted the Company a certificate of service authority to provide intrastate telecommunication services in File No. TA-92-17. The Company states that it has no customers in Missouri and no longer needs the certificate.

On January 27, 2022, the Commission issued an order that anyone wishing to file an objection or request a hearing do so no later than February 7, 2022. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

On February 24, 2022, the Staff of the Commission (Staff) filed its *Staff*Recommendation in which it advised that the Company had met the requirements of

Commission Rule 20 CSR 4240-28.011(3). Staff recommended that the Commission issue an order cancelling the certificate of service authority and any associated tariffs.

The Commission will follow Staff's recommendation and cancel the certificate of authority of the Company. The Company has no currently effective tariffs on file with the Commission.

THE COMMISSION ORDERS THAT:

- The certificate of service authority to provide intrastate telecommunication services granted to Value-Added Communications Services, Inc. d/b/a GTL in File No. TA-92-17 is canceled.
 - 2. This order shall be effective on March 30, 2022.
 - 3. This file shall be closed on March 31, 2022.
