## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 19, 2009

Effective Date: July 1, 2009

On May 12, 2009, Comcast Business Communications, LLC ("CBC") filed notification for the discontinuance and of services and requesting the Commission cancel their certificates of service authority and accompanying tariff. CBC has been authorized to offer interexchange intrastate and non-switched local exchange telecommunication services by the Commission.

In File Number TA-98-510, the Commission granted CBC a certificate of service authority to provide interexchange intrastate and non-switched local exchange telecommunication services. In File Number TN-2007-0398, the Commission approved the company's tariff, P.S.C. MO No. 1.

On June 4, 2009, the Commission directed the Staff of the Missouri Public Service Commission to file a Staff Recommendation regarding CBC's notification for the discontinuance of service. On June 15, 2009, the Staff filed its recommendation and stated that the company is no longer providing

telecommunications services in Missouri. Staff recommended the cancellation of the company's certificates and tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's notification and Staff's recommendation to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Comcast Business Communications, LLC, shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange intrastate and non-switched local exchange telecommunications services granted to Comcast Business Communications, LLC, in File Number TA-98-510, is canceled.
2. Comcast Business Communications, LLC's tariff, P.S.C. MO No. 1, is canceled.

3. This order shall become effective on July 1, 2009.
4. This file may be closed on July 2, 2009.
