ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 29, 2009 Effective Date: July 4, 2009

On May 27, 2009, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of NOW Intermedia, Inc. ("NOW") to provide intrastate interexchange and nonswitched local exchange telecommunications service in Missouri.

In Case Number XA-2003-0495, the Commission granted NOW a certificate of service authority to provide intrastate interexchange and nonswithced local exchange telecommunications service. NOW's tariff, P.S.C. Tariff No. 1, was also approved.

Staff's motion states that according to the Missouri Secretary of State's Office, the company failed to submit an annual report and was administratively dissolved on February 18, 2004.

Staff's Motion indicates NOW has not submitted annual reports for 2007 and 2008. In addition, NOW has not paid its Fiscal Year 2009 assessment of \$16.23 to the Commission.

Pursuant to Section 506.150, RSMo 2000, Staff's Motion has been served on both the Missouri Secretary of State's Office and the last registered agent for NOW. Neither service copies have been returned as undeliverable.

Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications service and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to NOW Intermedia, Inc. shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of service authority to provide intrastate interexchange and nonswtiched local exchange telecommunications service, granted to NOW Intermedia, Inc. in Case Number XA-2003-0495, is canceled.
 - 2. NOW Intermedia, Inc.'s tariff, P.S.C. Tariff No. 1, is canceled.
 - 3. This order shall become effective on July 9, 2009.
 - 4. This case may be closed on July 10, 2009.
