MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority in Missouri of Andiamo Telecom, LLC (“the Company) and states as follows:

1. On August 25, 2004, the Commission granted a certificate of interexchange telecommunications service authority to the Company in Case No. XA-2005-0030.

2. On June 7, 2010, the Commission received information that the Company no longer offered telecommunications service in Missouri and that its Certificate of Service Authority and its tariff could be cancelled, a copy of which is attached. On June 23, that information was confirmed.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the tariff and certificate of service authority of Andiamo Telecom, LLC to provide interexchange telecommunications service in Missouri.


