## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 23, 2007 Effective Date: September 2, 2007

On June 14, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariff of North American Telephone Network, LLC, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-96-310, the Commission granted North American Telephone Network a certificate of service authority to provide intrastate interexchange telecommunications services. The Commission also approved the company's tariff, P.S.C. Mo. No. 1.

Staff's motion states that through a letter from North American Telephone Network's chief operating officer, North American Telephone Network has requested the Commission cancel its certificate of service authority because it ceased all regulated operations in Missouri. North American Telephone Network owes no annual reports or assessments and no complaints have been filed

against the company since the commencement of the Commission's Electronic Filing and Information System, and any informal complaints or inquiries received have been closed. North American Telephone Network has failed to submit its annual report for calendar year 2006, but has submitted previous annual reports. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. Mo. No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and North American Telephone Network's request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to North American Telephone Network, LLC, shall be canceled.

## IT IS ORDERED THAT:

- The certificate of authority to provide intrastate interexchange telecommunications services granted to North American Telephone Network, LLC, in Case Number TA-96-310, is canceled.
- 2. North American Telephone Network, LLC's tariff, P.S.C. Mo. No. 1, granted in Case No. TA-96-310, is canceled.
  - 3. This order shall become effective on September 2, 2007.

4. This case may be closed on September 3, 2007.
