ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 30, 2016

Effective Date: July 10, 2016

On XD-2016-0337, the Staff of the Missouri Public Service Commission filed a motion requesting Yestel USA, Inc.'s ("Yestel") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled.

In File Number TA-2007-0423, the Commission granted Yestel a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Yestel failed to file Statements of Revenue for calendar years 2013, 2014 and 2015. It did not pay its Fiscal Year assessment of \$46.77. Also, Yestel's telephone mailbox was "full" as of April 14, 2016, and the US Postal Service returned mail on February 9, 2016. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On June 15, 2016, the Commission issued an Order Establishing Time to Respond allowing parties until June 27, 2016, to file an objection or request a hearing. No objections or requests for a hearing were filed.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Yestel USA, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Yestel USA, Inc., in File Number TA-2007-0423, is canceled.
2. Yestel USA, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on July 10, 2016.
4. This case may be closed on July 11, 2016.




