## MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority and applicable tariff of Impact Telecom, Inc., (Company) and states:

- 1. The Commission previously granted a certificate to the Company to provide intrastate interexchange service authority in Case No. XA-2012-0295 on April 25, 2012. The Company has an applicable tariff, No. YX-2012-0510.
- 2. The Company notified the Commission December 12, 2014, in a letter filed as Non-Case filing BNIR-2015-0314, that all of the customers of Impact Telecom, Inc., and Americatel Corporation were being transferred to Matrix Telecom, Inc. A copy of that letter has been attached here as Appendix A. Inadvertently, the certificate of service authority for Americatel Corporation was properly cancelled pursuant to the letter, but Impact Telecom, Inc.'s certificate remained in effect. Therefore, Staff now files this *Motion* to finalize the process.
- 3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications services and applicable tariff of Impact Telecom, Inc.; and grant such other and further relief as is just in the circumstances.



## PETITION FOR LEAVE TO TRANSFER CUSTOMERS

of

## IMPACT TELECOM, INC. AND AMERICATEL CORPORATION

to

## MATRIX TELECOM, INC.

Impact Telecom, Inc. ("Impact") and Americatel Corporation d/b/a 1010 123 Americatel d/b/a Startec ("Americatel") and Matrix Telecom, Inc. d/b/a Matrix Business Technologies ("Matrix") hereby seek approval of the planned transfer of customers from Impact and Americatel to Matrix. Following the anticipated January 1,2015 transfer, Impact and Americatel will no longer operate. Both companies request that the Commission cancel their authority upon approval of this merger filing.

#### I. THE PARTIES

Impact was incorporated under the laws of the State of Nevada on May 25, 2005. Its principal office is located in Englewood, Colorado. The company was originally authorized to provide resold interexchange service in File No. XA-2012-0295. Impact provides wholesale services only within Missouri. Impact is also the parent holding company of Matrix and Americatel.

Americated Corporation was incorporated under the laws of the State of Delaware on April 4, 1992. Its principal offices are also located in Irving, Texas. The company was originally authorized to provide interexchange services in TO-99-188 by order issued I1/27/98. Americated currently offers casual calling and presubscribed interexchange services within Missouri. Americated is a wholly owned subsidiary of Impact.

Matrix was incorporated under the laws of the State of Texas on June 13, 1990. Its principal offices are also located in Irving, Texas. The company was originally authorized to provide interexchange services in XA-2004-0238 by order issued 1/18/2004. The Company also received Commission approval to provide resold and facilities-based competitive local exchange services on 10/31/2005 in CA-2005-0393(C);YC-2005-0947(T). Matrix currently offers presubscribed interexchange and local services in Missouri. Matrix is also a wholly owned subsidiary of Impact.

Matrix also is certificated within Missouri under the names of IE Com, Excel Telecommunications

(TA-2013-0364) and VarTec Telecom (TA-2013-0363). The Company will, upon completion of this merger

and subsequent pricing guide revisions, file separate subsequent applications with the Commission to cancel

these authorizes as well.

II. THE TRANSACTION

The customers of Americatel and Impact will be transferred to Matrix beginning on or about January 1,

2015 pending all regulatory approvals. Following the transaction, these customers will be served by Matrix.

Matrix will revise its tariffs to incorporate the applicable transferred services upon completion of the transfer.

Americatel and Impact will cease to operate after that point in time and a request to cancel their authority will

be filed with the Commission upon approval of this merger filing. After the transaction is complete Matrix will

still be a wholly owned subsidiary of Impact Telecom, Inc.

Exhibit A contains an overview of the pre and post corporate structure of Impact Telecom once the

transfer and merger is completed.

III. CUSTOMER IMPACT

The transition to Matrix will be virtually transparent to most customers. Impact and Americatel's

customers will not incur any charges as a result of the change in service provider to Matrix. Additionally

Matrix will file with the Commission to add the d/b/a names of Impact Telecom and Americatel to ensure

customers that they are still being served under the same service plan.

Written notice of the proposed transfer was provided to Americatel's customers on or about November

20, 2014. The customer notification will advise customers of the following: (1) the pending change of their

interexchange service carrier selection to Matrix; (2) there will be no interruption of their service; (3) either

there will be no change to rates, terms or conditions of service OR a description of the proposed new service;

(4) there will be no charges associated with their change to Matrix as their interexchange carrier; (5) they have

the option to select a different service provider if they prefer, with no penalty from Americatel. The notification

will also include the toll free numbers which customers may call for more information. A copy of the customer

notification is attached as Exhibit B.




