ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 24, 2012

Effective Date: February 4, 2012

On December 28, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Key Communication Management Inc., d/b/a Discount Plus ("Discount Plus") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-96-143, the Commission granted Discount Plus a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that in 2009 Discount Plus failed to renew its fictitious name registration with the Missouri Secretary of State. Discount Plus owes the Commission assessments for Fiscal Year 2012. In addition, Discount Plus is deficient in the filing of the Company's 2010 annual report. Staff recommends that the Commission cancel the company's certificate of service authority to provide

intrastate interexchange telecommunications services, and the company's accompanying tariff, as the company is no longer lawfully provide telecommunications services in Missouri.

On December 29, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than January 10, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Key Communication Management Inc., d/b/a Discount Plus, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Key Communication Management Inc., d/b/a Discount Plus, in File Number TA-96-143, is canceled.
2. Key Communication Management Inc., d/b/a Discount Plus's tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on February 4, 2012.

4. This case may be closed on February 5, 2012.
