## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 22, 2017

Effective Date: June 1, 2017

On May 4, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Alliance Group Services, Inc.'s ("Alliance") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled.

In File Number TA-99-57, the Commission granted Alliance a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that on July 20, 2016, Alliance notified the Commission that Alliance no longer wished to retain its certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On May 5, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until May 15, 2017, to file an objection or request a hearing. No objections or requests for a hearing were filed.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Alliance Group Services, Inc., shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange telecommunications services granted to Alliance Group Services, Inc., in File Number TA-99-57, is canceled.
2. Alliance Group Services, Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on June 1, 2017.
4. This case may be closed on June 2, 2017.


