#### ORDER CANCELING CERTIFICATE

Issue Date: August 8, 2017 Effective Date: August 18, 2017

On July 13, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting BG Spirit, LLC's ("BG Spirit") certificate of service authority to provide basic local exchange, nonswitched local exchange and interexchange telecommunication service in the State of Missouri be cancelled.

In File Number LA-2012-0287, the Commission granted BG Spirit a certificate of service authority to provide basic local exchange, nonswitched local exchange and interexchange telecommunication service in the State of Missouri.

Staff states in its motion that BG Spirit notified the Commission that the company was no longer providing service in Missouri and requested the Commission cancel BG Spirit's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide basic local exchange, nonswitched local exchange and interexchange telecommunications services.

On July 13, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until July 24, 2017, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to BG Spirit, LLC, shall be canceled.

#### THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide basic local exchange, nonswitched local exchange and interexchange telecommunications services granted to BG Spirit, LLC, in File Number LA-2012-0287, is canceled.
  - 2. This order shall become effective on August 18, 2017.
  - 3. This case may be closed on August 19, 2017.
