# ORDER CANCELLING SERVICE AUTHORITY TO PROVIDE INTERCHANGE TELECOMMUNICATION SERVICE

Issue Date: August 8, 2018 Effective Date: August 8, 2018

On July 26, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that Quasar Communications Corporation's ("Company") certificate of service authority to provide interchange telecommunication service in the State of Missouri be cancelled at the company's request. On May 23, 2005, the Commission had granted the Company a certificate of service authority to provide interchange telecommunication service in the State of Missouri in Case Number XA-2005-0385.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> On July 27, 2018, the Commission issued its Notice that anyone wishing to respond to Staff's Motion or wishing to request a hearing should do so by filing a pleading with the Missouri Public Service Commission no later than August 7, 2018. No such request or filing was received by the Commission. Therefore, the Commission may cancel the certificate based on Staff's motion.
