MOTION FOR CLARIFICATION

COME NOW the Staff of the Missouri Public Service Commission and submits this motion for clarification of the Commission's *Order Recognizing Change of Corporate Name and Order Approving Revised Tariff* issued October 29, 2002. In support of its request, Staff states:

- 1. On October 29, 2002, the Commission issued an *Order Recognizing Change of Corporate Name and Order Approving Revised Tariff*. In that *Order*, the Commission ordered "That the change of name from Intellicall Operator Services, Inc., to ILD is acknowledged."
- 2. The Commission has now received a request from the same regulatory consultants who initiated this case for the Commission to clarify that the Commission's *Order* ostensibly approving a formal change of name from Intellicall Operator Services, Inc. to ILD, in fact approved the use of ILD as a fictitious name by Intellicall Operator Services, Inc. The request is attached to this *Motion* as Attachment A. That action was what the company requested and what Staff recommended, and appears to have been the Commission's true intent in its *Order*.
- 3. In the body of the Commission's *Order*, the Commission correctly noted that Staff filed a recommendation in the case indicating no objection to the proposed tariff filing, which added the fictitious name "ILD" to the existing Intellicall Operator Services, Inc. tariff. That tariff, which was approved and remains in effect, correctly reflects the company name as "Intellicall Operator Services, Inc. d/b/a ILD" and needs no modification if the Commission grants this request.

- 4. Staff has no objection to the request received from the company's representatives.
- 5. Commission regulation 4 CSR 240-2.160(4) permits the Commission to correct its orders *nunc pro tune*.

WHEREFORE, Staff requests that the Commission clarify its *Order Recognizing Change* of Corporate Name and Order Approving Revised Tariff issued October 29, 2002 to indicate that Intellicall Operator Services, Inc. has authority to use the fictitious name ILD in Missouri.

ORDER RECOGNIZING CHANGE OF CORPORATE NAME AND ORDER APPROVING REVISED TARIFF

This order recognizes the applicant's name change and approves its revised tariff sheets.

Intellicall Operator Services, Inc., filed a letter with the Missouri Public Service Commission on October 15, 2002, reflecting that it had changed its name to ILD. Intellicall also filed revised tariff sheets with an effective date of November 15, 2002, under tariff number JX-2003-0841, for its telecommunications services in Missouri, and included a registration of fictitious name from the Missouri Secretary of State. At the request of the Staff of the Commission, Intellicall submitted substitute pages on October 22, 2002.

Staff filed a memorandum on October 28, 2002, stating Intellicall that was certificated to provide interexchange telecommunications 19, 1992. services June on in case number TA-92-210. Staff noted that Intellicall's proposed replacement tariff reflects the new fictitious name on all pages and makes the following additional revisions: 1) changes the company address on all pages; 2) adds new technical terms; 3) adds prepaid calling services; 4) eliminates the per-call surcharge and increases the per-minute rate for Affinity Travel Card service; and 5) adds a new payphone surcharge and a non-subscriber surcharge.

Staff has no objections to the proposed tariff filing, as amended, and recommends the Commission amend Intellicall's certificate of service authority to reflect the new name, Intellicall

Operator Services, Inc. d/b/a ILD, and approve the tariff pages set out below to become effective on November 15, 2002.

The Commission has reviewed Intellicall's letter, revised tariff, and Staff's recommendation, and finds that the new name should be recognized. The Commission further finds that the revised tariff reflecting that name should be approved.

IT IS THEREFORE ORDERED:
