STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize the use of the fictitious name "Integra Telecom" by Electric Lightwave, LLC.

2. The company has fulfilled the requirements of the Commission's rule governing name changes at 4 CSR 240-2.060(5) in that the request contains a clear statement of the old and new names, and the request was accompanied by (1) Registration of Fictitious Name issued by the Missouri Secretary of State (demonstrating that Electric Lightwave, LLC has registered the name Integra Telecom for use in Missouri); and (2) an adoption notice and revised tariff title page identifying the new name.

3. Customers have been notified of the name change in compliance with 4 CSR 240-3.545(20), and Staff has reviewed it and found it acceptable.

4. In conjunction with and to effectuate the name change, the company has submitted an adoption notice and revised tariff sheet. These sheets bear an effective date of August 18, 2006, but that effective date was extended by the company to September 1, 2006 to permit additional time for the company to complete and Staff to review the necessary filings. The parties now no longer require this additional time, and Staff has reviewed these tariff sheets

and recommends that the Commission approve them with the initial effective date of August 18, 2006, or as soon as possible thereafter.

WHEREFORE, Staff recommends that the Commission issue an order acknowledging that Electric Lightwave, LLC will do business under the fictitious name of Integra Telecom; and approving the tariff sheets filed to effectuate that name change with an effective date of August 18, 2006 or as soon as possible thereafter.

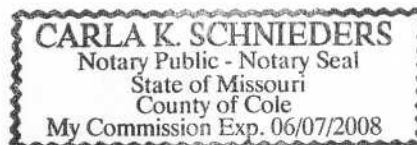

On July 6, 2006, the Commission issued an Order Directing Filing directing Electric Lightwave, LLC (ELI) to file a supplemental pleading including evidence of registration of the name change with the Missouri Secretary of State, and to file either an adoption notice and revised title sheet or a revised tariff. On July 18, 2006, ELI filed an adoption notice and revised title sheet. On August 8, 2006, ELI filed evidence of registration of the name change with the Missouri Secretary of State.

Staff notes that ELI requested an extension of the tariff's effective date to September 1, 2006, because it did not anticipate being able to file its supplemental pleading in time to meet its requested August 18, 2006, effective date. However, since all required documents have now been filed, Staff recommends that an effective date of August 18, 2006, be approved.
