STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

- 1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize that ASC Telecom, Inc. has ceased using its fictitious name of "AlternaTel" and is now returned to doing business solely under its own name. The Commission granted ASC Telecom, Inc. authority to use this fictitious name in Case No. TO-2000-464. On a technical level, the company has fulfilled the name change requirements as the company submitted the documents in its initial application case, Case No. TA-96-260, required to obtain authority to use the name ASC Telecom, Inc.
- 2. As the Applicant has no Missouri customers for its "AlternaTel" branded services, Staff has not recommended that the Applicant provide notice of the name change.
- 3. In conjunction with the name change, the Applicant has submitted revised tariff sheets comprising with an effective date of August 12, 2005.
- 4. Also as part of this tariff sheet filing, ASC has filed sheets indicating that it will no longer offer operator services to new customers. Staff recommends the Commission approve the tariff sheets because they meet the requirements of all applicable statutes, specifically, one or more of the following: Sections 392.200(8), 392.200(4), 392.455(4), 392.515(1) and 392.500(2) RSMo. 2000.

WHEREFORE, Staff recommends that the Commission issue an order acknowledging that ASC Telecom, Inc. will no longer use the fictitious name "AlternaTel" and will now do business solely under its own name; and approving the tariff sheets filed in conjunction with this case.
