ORDER DIRECTING STAFF TO INVESTIGATE AND FILE A REPORT

On February 13, 2007, Global Internetworking, Inc. ("Global Internetworking") filed a cover letter and accompanying application requesting that the Missouri Public Service Commission acknowledge a corporate name change to Global Telecom & Technology Americas, Inc. ("Global Telecom") and approve a revised tariff reflecting that name change.

Accompanying the cover letter and application are documents showing that Global Internetworking, a Virginia corporation, amended its Articles of Incorporation to change its corporate name to Global Telecom effective November 1, 2006, and that on January 22, 2007, the Missouri Secretary of State issued Global Telecom an Amended Certificate of Authority to do business in the State of Missouri as a foreign corporation.

Also attached are replacement tariff sheets with an effective date of March 14, 2007, including an adoption notice and a new title page, which reflect the name change and have been designated as Tariff No. YX-2007-0561. Finally, the cover letter indicates that Global Internetworking intends to inform its customers of the name change using a bill insert, which will include both company logos.

Global Internetworking's submission is in substantial compliance with the applicable Commission Rules governing the contents of applications for corporate name changes and setting forth filing requirements for telecommunications company tariffs.¹

The Commission would like to have the benefit of a brief investigation by its Staff before it further considers this matter. Therefore, Staff will be directed to commence an investigation and promptly file a report containing its recommendation as to whether the Commission should recognize Global Internetworking's name change and approve the accompanying replacement tariff sheets.

IT IS ORDERED THAT:

- 1. The Staff of the Missouri Public Service Commission shall promptly commence an investigation into the merits of the application filed by Global Internetworking, Inc. on February 13, 2007.
- 2. The Staff of the Missouri Public Service Commission shall file a report concerning the results of its investigation by no later than Friday, March 9, 2007.
 - 3. This order shall become effective on February 16, 2007.
