ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF SHEETS

Issue Date: September 11, 2008

Effective Date: September 19, 2008

Syllabus: This order recognizes AmeriVon LLC's name change to V-Global Communications, LLC, and approves the accompanying tariff sheets.

On July 3, the Commission received the above-referenced request for name change. It was filed pursuant to Commission Rule 4 CSR 240-2.060(5). The Commission issued a Notice of Deficiency on July 8, due to the applicant's failure to submit either an adoption notice and revised tariff title sheet, or revised tariff sheets.

On August 20, in an attempt to correct the deficiency, the applicant filed Missouri PSC Tariff No. 1, Original Page No. 1, which the Commission assigned Tariff No. YX-2009-0133. It has an effective date of September 20, 2008. The applicant filed substitute sheets on September 10, containing an effective date of September 19.

On September 11, Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the new tariff.

The Commission has reviewed the application and finds that it substantially complies with Commission Rule 4 CSR 240-2.060(5). Further, the Commission finds that because

the applicant has no Missouri customers, Commission Rule 4 CSR 240-3.545(20) does not apply. The Commission concludes that it should recognize the name change and will approve the tariff sheets.

IT IS ORDERED THAT:

1. The Commission recognizes the name change of AmeriVon LLC to V-Global Communications, LLC.
2. The Commission approves the tariff sheets V-Global Communications, LLC filed on August 20, 2008, as substituted on September 10, 2008, reflecting its new name. Those tariff sheets were assigned tariff file number YX-2009-0133, and are approved for service on and after September 19, 2008. The tariff sheets approved are:

3. This order shall become effective on September 19, 2008.
4. This case shall be closed on September 20, 2008.
