**STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through the undersigned counsel, and hereby respectfully submits this Staff Recommendation.

1. On July 11, 2011, the above-reference company filed a notice of a name change and then filed a tariff adoption bearing an effective date of July 21, 2011. The company filed a copy of the customer notice, as well as documentation showing that its new name is registered with the Secretary of State.

2. Rule 4 CSR 240-2.062 establishes filing requirements for certificated company name changes; with the exceptions noted above, the Company has complied with the rule. No entities intervened to oppose the name change. The Company is not delinquent in any required filings with the Commission. The filed tariff adoption sheets are compliant with Commission rules.

**WHEREFORE**, the Staff recommends that the Commission recognize the name change and either approve the tariff adoption notice or allow it to take effect by operation of law.
