**ORDER CANCELLING INTEREXCHANGE  
CERTIFICATE OF SERVICE AUTHORITY**

Issue Date: June 28, 2023

Effective Date: July 28, 2023

On May 31, 2023, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority to provide intrastate interexchange telecommunications service and applicable tariff of Multiline Long Distance, Inc. ("the Company"). On January 1, 2007, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. XA-2007-0191. The Company also has an applicable tariff, Tracking No. YX-2007-0345. Staff's motion stated that the Company wishes to cancel the certificate and applicable tariff. The Company stated that it no longer offers telecommunications services in Missouri and that no customers will be affected.

On June 5, 2023, the Commission issued an order that anyone wishing to file an objection or request a hearing do so no later than June 15, 2023. There were no such filings. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, the Commission will cancel the certificate based on Staff's motion.

1. The certificate of authority to provide intrastate interexchange telecommunications service granted to Multiline Long Distance, Inc. and the applicable tariff, Tracking No. YX-2007-0345, are canceled.
2. This order shall be effective on July 28, 2023.
3. This file shall be closed on July 31, 2023.

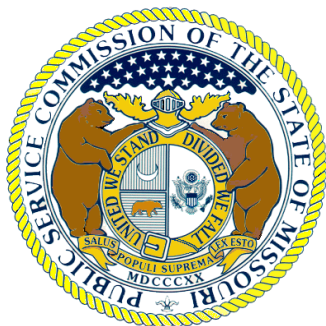
