STAFF MEMORANDUM AND RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and states:

- 1. On May 27, 2008, Reduced Rate Long Distance, LLC (RRLD) and Horizon Telecom, Inc. (Horizon) filed a joint application seeking approval of a transfer of assets wherein RRLD will acquire the assets of Horizon including customer accounts.
- 2. The Commission granted RRLD a certificate of service authority to provide interexchange telecommunications services in Case No. TA-2002-55. Horizon was granted a certificate of service authority to provide interexchange telecommunications services in Case No. XA-2003-0180. Both companies are in good standing with the Missouri Secretary of State.
- 3. On July 7, 2008, the joint applicants filed revised tariff sheets and a Motion for Expedited Treatment and approval of their tariff pages by July 19, 2008, or as soon thereafter as the Commission's final order approving the transfer is effective.
- 4. The transfer of assets is governed by Section 392.300 and 4 CSR 240-3.520. Applicable case law provides that the Commission may "not withhold its approval of the disposition of assets unless it can be shown that such disposition is detrimental to the public interest." *State ex rel. Fee Fee Trunk Sewer, Inc. v. Litz,* 596 S.W.2d 466, 468 (Mo.App. E.D. 1980), citing to *State ex rel. City of St. Louis v. Public Serv. Comm'n of Mo.,* 73 S.W.2d 393, 400 (Mo. banc 1934).

5. In the attached Memorandum, the Staff summarizes its review of the transaction between the Applicants, and concludes that the transfer of assets will not be detrimental to the public interest. Staff recommends that the Commission approve the sale of assets, grant expedited treatment, approve RRLD's tariffs before August 6, 2008, and cancel Horizon's certificate and tariffs.

WHEREFORE, Staff recommends the Commission approve the application and tariff sheets at its earliest convenience.
