STAFF RECOMMENDATION


COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and hereby respectfully submits this Staff Recommendation.

1. On July 29, 2010, the above-reference company filed an application for name change, as well as a tariff adoption notice as required in 4 CSR 240-2.060(5), with an effective date of August 28, 2010. The company did not file a copy of the customer notice, as also required by the rule. The Company supplemented its application with a copy of the customer notice, which notice complies with Commission rules.

2. Rule 4 CSR 240-2.060 establishes filing requirements for certificated company name changes; as noted in the Staff Recommendation, attached hereto as Attachment A, the Company has complied with the rule. No entities intervened to oppose the name change. The Company is not delinquent in any required filings with the Commission. The filed revised tariff sheets are compliant with Commission rules.

WHEREFORE, the Staff recommends that the Application and accompanying tariff be approved.
