### ORDER GRANTING INTERVENTION

Issue Date: August 8, 2018 Effective Date: August 8, 2018

On July 24, 2018, the Advanced Energy Management Alliance ("AEMA") filed an Application to Intervene Out-of-Time ("Application"). AEMA filed the untimely application because the Commission's order for supplemental direct testimony concerning Distributed Energy Resources was not issued until after the deadline to apply for intervention. AEMA states that it accepts the record established in this case as of the date of the Application. Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company oppose intervention, stating that their future MEEIA filing would be a more appropriate venue for AEMA to intervene.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting

intervention would serve the public interest. Commission Rule 4 CSER 240-2.075(10) allows the Commission to grant untimely intervention requests upon a showing of good cause. The Application shows the required statement that AEMA accepts the record established in this case. Upon review of the Application, the Commission finds AEMA meets the standard in Commission Rule 4 CSR 240-2.075(4), and finds good cause to allow AEMA to intervene out of time. Therefore, the Commission will grant the Application.

#### THE COMMISSION ORDERS THAT:

- 1. The application to intervene out-of-time filed by Advanced Energy Management Alliance is granted.
  - 2. This order shall be effective when issued.
