ORDER REGARDING MOTION TO ENFORCE RULES AND ORDER

On June 27, 2018, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") (collectively, "Companies") filed a Notice of Public Counsel's Stated Intent to Violate PSC Rules and Procedural Order, and Motion to Enforce Rules and Order ("motion"). In the motion, Companies state that the Office of Public Counsel ("OPC") fail to state its case-in-chief in its direct testimony as required by Commission rules.

As such, Companies argue that OPC has violated their due process rights by delaying its case-in-chief until rebuttal or surrebuttal testimony. For relief, Companies ask the Commission to not permit OPC to supplement its case-in-chief via rebuttal or surrebuttal.

Because rebuttal testimony has not yet been filed, the Commission and the parties have no way of knowing whether such rebuttal testimony will violate Commission rules or its March 13, 2018 procedural order. Thus, Companies' request is not yet ripe for review.

THE COMMISSION ORDERS THAT:

- The Notice of Public Counsel's Stated Intent to Violate PSC Rules and Procedural Order, and Motion to Enforce Rules and Order is denied as not yet being ripe for review.
