NOTICE OF WITHDRAWAL

COMES NOW the Staff of the Missouri Public Service Commission and for its Notice states:

1. On August 11, 2010, the Commission received a notice that an additional fictitious name (TCI Long Distance) would be used by OPEX Communications, Inc., together with tariff adoption notice purporting to allow TCI Long Distance to adopt OPEX's tariff. On August 31, the Staff filed a Motion to Dismiss, based on its belief that the requested relief could not be granted, largely due to the form of the request.

2. Later that day, after discussing various options available to OPEX that could achieve its goals, the Staff received the attached e-mail from OPEX, asking that its filing be withdrawn. The Staff believes that such withdrawal is the most expedient way for the Company to proceed with its request in a proper form, and that such withdrawal will not prejudice its future efforts.

3. As there has been no tariff suspension in this matter, this case is not a contested case and the Staff believes that OPEX may withdraw without leave or prejudice.

WHEREFORE, the Staff respectfully requests that the Commission accept OPEX's withdrawal, indicate that such withdrawal does not prejudice OPEX in any way, and close this file.
