On June 27, 2018, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") filed a "Notice of Public Counsel's Stated Intent to Violate PSC Rules and Procedural Order, and Motion to Enforce Rules and Order" ("Motion"). In the motion, KCP&L and GMO complain that the Office of Public Counsel ("OPC") withheld information from its' direct testimony filing, stating that it may update its positions in rebuttal or surrebuttal testimony. KCP&L and GMO argue that this withholding violates Commission Rules requiring parties to file all testimony explaining its case-in-chief in direct testimony.

OPC responded on June 28, 2018, stating that a case-in-chief is only for parties with the burden of proof; namely, KCP&L and GMO. OPC simply filed direct testimony it was not required to file, and it should have the ability to offer whatever rebuttal or surrebuttal evidence it chooses to offer.

The Commission will order its Staff to respond to these arguments, and will permit other parties to respond if they wish.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall respond as ordered above no later than July 6, 2018.

2. Any other party who wishes to respond shall do so no later than July 6,

2018.

3. This order shall be effective when issued.
