ORDER DIRECTING RESPONSE

On July 16, 2018, Union Electric Company d/b/a Ameren Missouri filed a tariff purporting to comply with the Commission's July 5 order approving a stipulation among the parties that will reduce Ameren Missouri's electric rates. That tariff carries a thirty-day effective date of August 15. But, along with its tariff, Ameren Missouri filed a motion for expedited treatment that asks the Commission to approve the tariff to take effect on August 1, the effective date specified in the approved stipulation and agreement.

The Commission will order its Staff to file a recommendation advising whether Ameren Missouri's tariff complies with the Commission's order and the stipulation and agreement.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Ameren Missouri's tariff no later than July 18, 2018.
2. Any other party wishing to file a recommendation regarding Ameren Missouri's tariff shall do so no later than July 18, 2018.

3. This order shall be effective when issued.
