**ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF**

Issue Date: August 10, 2005

Effective Date: August 12, 2005

ASC Telecom, Inc., submitted revised tariff sheets on July 12, 2005, designed to reflect that it will no longer be operating under the fictitious name AlternaTel. ASC also revised its tariff so that it is no longer offering operator services to new customers. ASC's tariff has a proposed effective date of August 12, 2005. Substitute sheets were filed on July 15, 2005, July 21, 2005, and August 4, 2005.

The Staff of the Missouri Public Service Commission filed a recommendation on July 28, 2005, stating that it had reviewed the company's tariff and recommending approval of the name change and of the other revisions to the tariff sheets.

The Commission has reviewed ASC's tariff filing, the substitute tariff sheets, and Staff's recommendation, and finds that the deletion of the fictitious name should be recognized. The Commission further finds that the tariff sheets should be approved.

**IT IS THEREFORE ORDERED:**

1. That the deletion of the fictitious name "AlternaTel" is recognized.
2. That the tariff sheets filed by ASC Telecom, Inc., on July 12, 2005, and amended on July 15, 2005, July 21, 2005, and August 4, 2005, Tariff File No. YX-2006-0016,

are approved as amended for service on and after August 12, 2005. The tariff sheets approved are:
