**ORDER RECOGNIZING NAME CHANGE
AND APPROVING TARIFF SHEETS**

Issue Date: January 10, 2013

Effective Date: January 20, 2013

On December 26, 2012, the Commission received the above-referenced request for name change. Accompanying the request was the above-referenced tariff, which bears an effective date of January 20, 2013.

On January 9, 2013 Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the tariff sheets.

Staff further notes that the applicant is delinquent in filing its annual reports with the Commission. Staff recommends that the Commission order the applicant to file its 2011 annual report within 30 days of the date of the order.

The Commission has reviewed the application, finds that it substantially complies with Commission Rule 4 CSR 240-2.062, and finds that it should recognize the name change. The Commission will also approve the tariff.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of DeltaCom, Inc. d/b/a EarthLink Business to DeltaCom, LLC d/b/a EarthLink Business.

2. The Commission approves the tariff sheets DeltaCom, LLC d/b/a EarthLink Business filed on December 26, 2012, reflecting its new name. Those tariff sheets were assigned tariff file number YX-2013-0293, and are approved for service on and after January 20, 2013. The tariff sheets approved are:

3. DeltaCom, LLC d/b/a EarthLink Business shall file its 2011 annual report within 30 days of the date of this order. Should DeltaCom, LLC d/b/a EarthLink Business fail to comply, the Staff of the Commission is authorized to file a complaint at the Commission against DeltaCom, LLC d/b/a EarthLink Business.

4. This order shall become effective on January 20, 2013.

5. This case shall be closed on January 21, 2013.
