ORDER RECOGNIZING NAME CHANGE

Issue Date: January 15, 2015

Effective Date: January 22, 2015

On January 12, 2015, Tri-M Communications, Inc. asked the Commission to recognize its name change from Tri-M Communications Inc. to Globalinx Enterprises, Inc. The company also filed a revised tariff to be effective January 22.

In response, the Commission directed its Staff to file a recommendation regarding that request by January 16. Staff's recommendation, filed on January 15, advises the Commission that the notice of name change and the revised tariff title sheet comply with the Commission's requirements for a name change. Staff recommends the Commission recognize the name change for all the certificates held by the company, including its IVoIP Registration, and either approve the tariff or allow it to go into effect. No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff's recommendation. The Commission finds that the name change should be recognized.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the change of name of Tri-M Communications, Inc. to Globalinx Enterprises, Inc.

2. The revised tariff filed by Globalinx Enterprises, Inc. is approved to be effective on January 22, 2015. The tariff approved is:
