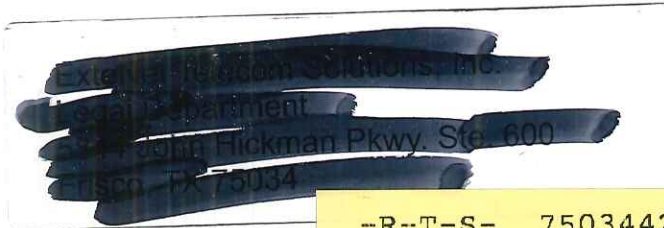

ORDER RECOGNIZING NAME CHANGE

Hudson Fiber Network, Inc. submitted a letter on November 22, 2022, advising that it changed its name from Hudson Fiber Network, Inc. to ExteNet Telecom Solutions, Inc. The company is authorized to provide non-switched local telecommunication and interexchange telecommunication services as set forth in File No. TA-2019-0409.

On May 30, 2023, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes Hudson Fiber Network, Inc.'s name change to ExteNet Telecom Solutions, Inc.
2. This order shall be effective on June 29, 2023.




