### ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On April 17, 2018, TeleQuality Communications, LLC submitted a cover letter and a revised tariff, issued and effective on April 18, 2018, that substitutes specific rates for the maximum and minimum rates described in the company's old tariffs. The cover letter explains that TeleQuality offers telecommunications services to health care providers in predominantly rural areas of Missouri under the federal Rural Health Care (RHC) program. It cites a Federal Communications Commission regulation – 47 C.F.R. 54.607(b) – that requires TeleQuality to submit its intrastate rates for such telecommunications services to the applicable state commission for approval. As required by the federal regulation, TeleQuality has submitted a confidential itemized cost study purporting to demonstrate that each rate is cost-based.

The cover letter also notes that the submitted tariff reflects a change in the company's name from TeleQuality Communications, Inc. to TeleQuality Communications, LLC.

The Commission will direct its Staff to file a recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding TeleQuality Communications, LLC's request and tariff no later than May 18, 2018.
  - 2. This order shall be effective when issued.
