ORDER MODIFYING ORDER **GRANTING MOTION TO CONSOLIDATE**

On March 2, 2018, the Staff of the Commission filed a Motion to Consolidate Cases and Proposed Procedural Schedule. 1 The Commission granted that motion on March 13, 2018.

The Commission may, on its own motion, reconsider or otherwise amend any order.2 Upon reconsideration, the Commission finds that it shall hear these two rate cases simultaneously in a joint hearing because of the common questions of law and fact involved.³ But, because these are two rate cases filed by two different companies, these cases shall remain separate.

The portion of the March 13, 2018 order consolidating these two cases, with File No. ER-2018-0145 being the lead file, is abrogated. Parties shall file documents

and pleadings in either File No. ER-2018-0145, ER-2018-0146, or both, as appropriate. Parties may file substantially similar or identical documents or pleadings in both cases by simply referencing both ER-2018-0145 and ER-2018-0146 on the filings. All other portions of the March 13 order, including the procedural schedule and other directives, remain in full force and effect.

THE COMMISSION ORDERS THAT:

- 1. The Commission's March 13, 2018 Order Granting Motion to Consolidate and Order Setting Procedural Schedule is modified as ordered above. File No. ER-2018-0145 is no longer the lead case. Further documents and pleadings related to either File No. ER-2018-0145 or ER-2018-0146 shall be filed in the appropriate file or files as ordered above.
 - 2. This order shall be effective when issued.
