

**ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND
DIRECTING FILING OF STAFF RECOMMENDATION**

On November 30, 2018, Kansas City Power & Light Company ("KCPL") filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. Commission Rule 4 CSR 240-20.093(4) requires the Commission's Staff to examine and analyze the information KCPL has filed and to submit a recommendation no later than 30 days after KCPL filed its tariff revision. Because that 30th day falls on a Sunday, Staff's recommendation will be due no later than Monday, December 31, 2018. The Commission must then act on KCPL's tariff filing before January 29, 2019.

The Commission will establish a deadline for any other entity that may wish to apply to intervene and will direct its Data Center to serve a copy of this order upon the parties in EO-2015-0240 and upon the county commission of each county in KCPL's service area. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving KCPL's service area and to the members of the Missouri General Assembly representing the residents of KCPL's service area.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall add all parties from File No. EO-2015-0240 to the service list for this case.

2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Kansas City Power & Light Company.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of Kansas City Power & Light Company and to the news media serving the residents of the service territory of Kansas City Power & Light Company.

4. Any proper person or entity wishing to intervene in this matter shall file an application to intervene no later than December 17, 2018.

5. The Staff of the Commission shall file its recommendation no later than December 31, 2018.

6. This order shall be effective when issued.




