STAFF'S MOTION FOR AN EXTENSION OF TIME

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Motion for an Extension of Time*, states as follows:

- 1. On November 6, 2018, Kansas City Power and Light Company and Kansas City Power and Light Company Greater Missouri Operation (collectively, the "Company") filed its proposed tariffs intended to implement the Commission's approval of the four Stipulations and Agreements, embodied in its *Order Approving Stipulations* and Agreements ("Order"), issued October 31, 2018. These proposed tariffs are referred to as "Compliance Tariffs," and bear an effective date of December 6, 2018.
- 2. In the Order, the Commission directed that "The Staff of the Commission shall file a Recommendation on the above-referenced tariffs no later than November 9, 2018."
- 3. Staff states that it has diligently undertaken to review several hundred tariff sheets and that, as of now, it has found a number of instances in which Staff believes the proposed sheets need to be revised for technical reasons, or to more

accurately reflect the Commission's Order and the approved Stipulations and Agreements. Staff has advised the Company of each such instance and the Company is diligently working to correct those issues. The Company started filing its substitute tariff sheets purporting to address Staff's concerns at approximately 2:30 pm, today November 9, 2018. In order to review the substitute tariff sheets, Staff requests that the Commission grant Staff an extension to file its recommendation by November 16, 2018.

WHEREFORE, Staff prays that the Commission will grant an extension of time, up to and including Friday November 16, 2018, for the filing of its recommendation regarding the Company's Compliance Tariffs.
