APPLICATION OF DAVIDSON TELECOM, LLC FOR A CERTIFICATE OF SERVICE AUTHORITY AND FOR COMPETITIVE CLASSIFICATION

Comes now Davidson Telecom, LLC ("Davidson Telecom" or "Applicant"), by and through its undersigned counsel and pursuant to Sections 392.361, 392.410, 392.420, 392.430, 392.440, and 392.515 RSMo 2000, and 4 CSR 240-2.060, hereby requests that the Commission issue Davidson Telecom a Certificate of Service Authority to provide intrastate interexchange telecommunications services within the State of Missouri, classify Davidson Telecom as a competitive company, and waive certain statutes and rules. Specifically, Davidson Telecom seeks to provide intrastate interexchange telecommunications services within the State of Missouri pursuant to Section 392.515 RSMo 2000 and related rules of the Commission. In support of this Application, Davidson Telecom states as follows:

A. <u>Description of the Applicant</u>

1. Applicant's legal name is Davidson Telecom, LLC. Applicant is a Delaware limited liability company with its principal business office located at 19003 Hodestone Court, Davidson, NC 28036. The character of Davidson Telecom's business is to provide telecommunications service. Davidson Telecom's Certificate of Good Standing in the State of Missouri is provided in Exhibit A.

B. **Qualifications**

4. Applicant possesses the technical and managerial qualifications to provide telecommunications services within the State of Missouri. Applicant's key management personnel have both the business and telecommunications experience necessary to manage Applicant's operations in Missouri. Management biographies of the key management personnel of Applicant are attached hereto as Exhibit B.

5. Applicant also possesses the financial qualifications to provide telecommunications services.

C. <u>Description of Services</u>

6. Davidson Telecom proposes to provide intrastate interexchange telecommunications services throughout the State of Missouri and, therefore, seeks statewide authorization.

7. Davidson Telecom seeks authority to operate as a provider of intraLATA and interLATA interexchange telecommunications services (principally resold) to the public throughout the State of Missouri. Specifically, Davidson Telecom requests authority to provide a selected range of 1+ interexchange services and data transmission services, including, but not limited to, MTS, private line, prepaid calling card, toll free, ISDN, and frame relay service products. Davidson Telecom intends to offer both switched interexchange services and non-switched local exchange services.

8. Attached hereto as Exhibit C is Applicant's proposed Tariff. The tariff has an effective date which is 45-days after the tariff's issued date.

9. Davidson Telecom will continuously monitor and maintain a high level of control over its network on a 24-hours-a-day, 7 days-a-week basis.

10. Davidson Telecom will not unjustly discriminate among its subscribers, as prohibited by Section 392.200 RSMo.

11. Davidson Telecom does not have any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer service or customer rates, which action, judgment or decision has occurred within three (3) years of the date of this Application.

12. Since Davidson Telecom is requesting certification as a new carrier, no annual reports or fees are overdue.

D. Classification as a Competitive Company

13. Davidson Telecom seeks classification as a competitive company, pursuant to Sections 392.361.2 and 392.361.3 RSMo., and the accompanying reduced regulation, pursuant to Section 392.420 RSMo

14. Applicant respectfully requests that the Commission suspend, waive, or modify the application of the following rules and statutory provisions consistent with the Commission's treatment of other competitive carriers:

15. The above-referenced statutory provisions or regulations have been waived with regard to other competitive carriers. These statutory provisions or regulations are principally

designed to apply to noncompetitive telecommunications carriers. It would be inconsistent with the goal and purpose of Section 392.530 RSMo. to apply them to a competitive telecommunications carrier such as Applicant.

16. Davidson Telecom will comply with all orders and regulations of the Commission applicable to providers of competitive interexchange telecommunication services except those that are specifically waived by the Commission.

17. To the extent that the Commission may modify its current waiver policies, Davidson Telecom reserves the right to amend its waiver requests accordingly.

E. <u>Public Interest Considerations</u>

18. The entry of Davidson Telecom into the intrastate interexchange telecommunications services market will promote competition in the provision of telecommunications services within the State of Missouri. Moreover, the granting of Davidson Telecom's application will bring significant benefits to telecommunications users in Missouri. Applicant's expertise in the provision of its proposed services will allow it to provide economic and efficient services, thereby affording customers an optimal combination of price, quality, and customer service.

F. Conclusion

For the reasons stated above, Applicant respectfully submits that the public interest, convenience, and necessity would be furthered by a grant of this Application for a Certificate of Service Authority to provide intrastate interexchange telecommunications services, classify Davidson Telecom and its proposed services as competitive, and grant a waiver of the statutes and regulations referenced above.
