APPLICATION

COMES NOW **CTS Technology Solutions, Inc., an Illinois corporation**, (“Applicant”), pursuant to §392.550 RSMo Cum Supp. 2010, and for its application to the Missouri Public Service Commission (“Commission”) states as follows:

1. The Applicant’s legal name is **CTS Technology Solutions, Inc.** Applicant is an Illinois corporation registered with the Missouri Secretary of State as a foreign corporation and is in good standing. A copy of Applicant’s certificate of good standing is attached as Exhibit A. The Applicant seeks registration to offer and provide interconnected voice over Internet protocol service in all areas defined by the existing exchange areas in which Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri; Embarq Missouri, Inc. d/b/a Embarq; Spectra Communications Group, LLC d/b/a/ Century Tel; CenturyTel of Missouri L.L.C; Fidelity Telephone Company; and Windstream Missouri, Inc. are authorized to operate in Missouri. Essentially the Applicant seeks registration statewide.

3. Attached is an affidavit signed by an officer or general partner of the Applicant making the eight statements required by §392.550.3 RSMo, plus confirmation the Applicant’s

service meets the criteria of interconnected voice over Internet protocol service as defined by §386.020(23).

WHEREFORE, the Applicant requests the Commission to issue an order granting the Applicant a registration to offer and provide interconnected voice over Internet protocol service in the exchanges listed in the Affidavit.

(6) That the Applicant will remit the annual assessment imposed by the Commission under section 386.370, RSMo;

(7) That the Applicant will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission;

(8) That the Applicant has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. Consumer complaints may be directed to:

- (d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.

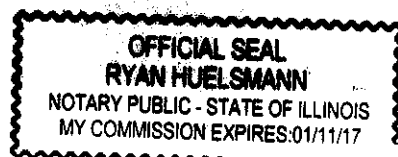

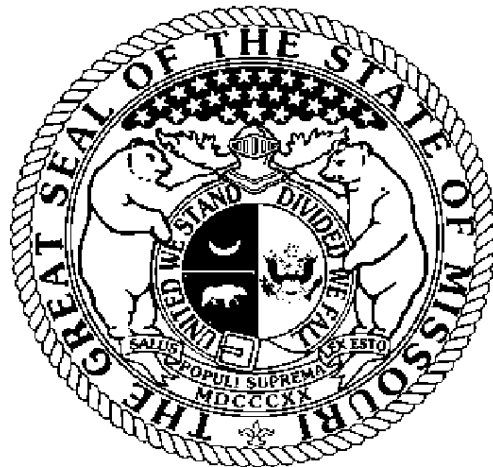
