- 1. On August 29, 2013, Applicant filed its application for registration to provide competitive prepaid interexchange telecommunications services pursuant to Sections 392.550 and 392.611 RSMo.
- 2. As of August 28, 2013, pursuant to Section 392.611.4, registration became an alternative to traditional certification, as follows:
- 4. After August 28, 2013, telecommunications companies seeking to provide telecommunications service may, in lieu of the process and requirements for certification set out in other sections, elect to obtain certification by following the same registration process set out in subsection 3 of section 392.550, substituting telecommunications service for interconnected voice over internet protocol service in the requirements specified in subdivisions (1) to (8) of subsection 3 of section 392.550.
- 3. Section 392.550.3 requires the Commission to "grant a registration without a hearing and no later than thirty days following the filing".
- 4. The Commission's Notice and Order Directing Filing issued August 29, 2013 purports to allow for interventions and a staff recommendation more than 30 days after the filing.

5. The Commission should reconsider its August 29, 2013 Notice and Order Directing Filing, to make plain that there can be no hearing in this matter and that a staff recommendation must be filed in time for the Commission to grant the registration within the statutory time limit of 30 days.

WHEREFORE, the Applicant requests the Commission to reconsider its August 29, 2013 Notice and Order Directing Filing, to make plain that there can be no hearing in this matter and that a staff recommendation must be filed in time for the Commission to grant the registration within the statutory time limit of 30 days.
