## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 11, 2006 Effective Date: July 21, 2006

On June 13, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Hierholzer Communications, Inc. d/b/a Andrew Communications, a company that has been authorized to offer intrastate interexchange telecommunications and nonswitched local exchange telecommunications services by the Commission.

In Case Number XA-2005-0023, the Commission granted Andrew Communications a certificate to provide intrastate interexchange telecommunications and nonswitched local exchange telecommunications services. In the same case, Andrew Communications's tariff, PSC Mo No. 1, was also approved.

Staff's motion states that the company's president, Brian Hierholzer, indicated in an electronic mail to Public Service Commission Counsel, David

Meyer, that Andrew Communications is no longer providing telecommunications services in Missouri and requested the cancellation of the company's certificate Further discussions with the company's regulatory consultant and tariff. confirmed that the company is not providing telecommunications services in Missouri. Furthermore, Andrew Communications has not submitted its 2005 annual report. The company owes no assessments to the Commission. No Complaints have been filed against Andrew Communications since the commencement of the Electronic Filing and Information System. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, PSC Mo No. 1, to provide intrastate interexchange telecommunications and nonswitched local exchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the president of Andrew Communications's request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Hierholzer Communications, Inc. d/b/a Andrew Communications, shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications and nonswitched local exchange telecommunications services granted to Hierholzer Communications, Inc. d/b/a Andrew Communications, in Case Number XA-2005-0023, is canceled.
  - 2. Andrew Communications's tariff, PSC Mo No. 1, is canceled.
  - 3. This order shall become effective on July 21, 2006.
  - 4. This case may be closed on July 22, 2006.
