ORDER DECLARING CERTIFICATE AND ACCOMPANYING TARIFF NULL AND VOID

Issue Date: May 28, 2009

Effective Date: June 7, 2009

On April 15, 2009, the Staff of the Commission filed a motion asking the Commission to declare Jefferson Plaza Investors, Inc., d/b/a Blue Springs Office Suites' certificate of service authority and the accompanying tariff null and void. The Commission authorized Blue Springs to offer competitive interexchange telecommunication services in the State of Missouri.

In File Number TA-99-452, the Commission granted Blue Springs a certificate of service authority to provide competitive interexchange telecommunications services. The Commission also approved the company's tariff, Mo. P.S.C. No. 1.

Staff's motion states that on March 30, 2009, the Commission received a ceasing operations statement from the Company requesting the Commission cancel their certificate and tariff. Blue Springs indicated they had never provided service under the interexchange certificate or tariff granted in TA-99-452. Staff further stated the company owes no past assessments to the Commission.

Staff recommends that the Commission declare the company's certificate of service authority and accompanying tariff, Mo. P.S.C. Tariff No. 1, to provide competitive interexchange telecommunications services, null and void.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request and Staff's motion to declare null and void the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Blue Springs, shall be null and void.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide competitive interexchange telecommunications services granted to Jefferson Plaza Investors, Inc., d/b/a Blue Springs Office Suites, in File Number TA-99-452, is null and void.

2. Jefferson Plaza Investors, Inc., d/b/a Blue Springs Office Suites' tariff, Mo. P.S.C. No. 1, granted in File No. TA-99-452, is null and void.

3. This order shall become effective on June 7, 2009.
4. This file may be closed on June 8, 2009.
